New HEB opens in Katy Park

H-E-B opened its 94th Houston-area location on Wednesday, Feb. 21, in Katy Park at 24924 Morton Ranch Drive, Katy, with an onsite DJ as well as surprises and delights for customers waiting in line.

A community check presentation was made just before the ribbon was officially cut. "H-E-B is passionately

committed to its customers beyond the four walls of its stores, weaving an undeniable Spirit of Giving into its business philosophy," company officials said in a press release. "In this spirit and in celebration of the grand opening, H-E-B will donate \$5,000 to Katy ISD's Miller Career & Technology Center Culinary Arts Program. The two-year program exposes students to a variety

of post-secondary options in the restaurant and service industry through hands-on experience including restaurant management, food preparation, food safety, and more while running the onsite bistro."

KISD board discusses chaplain program

Formal vote to be taken February 26th

In Monday night's work study meeting, the Katy ISD Board of Trustees discussed Senate Bill 763, which governs the employment or acceptance of volunteer services of chaplains by public school district and whether to adopt a policy authorizing the district to employ or accept as a volunteer, a chaplain under Texas Education Code Chapter 23.

Senate Bill 763 was approved in May 2023 and would allow Texas schools to use safety and security funds to pay for unlicensed religious chaplains to work on campus in mental health roles similar to those of school counselors. Volunteer chaplains would also be allowed in schools.

The bill requires that school districts vote by March 1 on whether to allow chaplains to serve as mental health counselors, either in paid or unpaid positions. The bill does not require any accreditation or licensing for chaplains.

Twelve individuals spoke on the matter during the public comments portion of the meeting prior to the board's discussion; eleven opposed the policy and one supported it. Those opposing the

KAEDC hears economic update from GHP's Jankowski

Members of the Katy Area Economic Development Council gathered on February 13th at the Katy campus of Houston Community College, 22910 Colonial Parkway, to hear Patrick Jankowski, chief economist and senior vice president for the Greater Houston Partnership, deliver his annual "state of the economy" presentation.

Jankowski began by stating that the U.S. economy is very robust and that a recession was avoided in 2023, in line with his prediction during his presentation to the EDC last year. Real EDP growth is strong at more than 3.4% and more than 353,000 jobs were created in January 2024, continuing a long trend of positive job growth.

Jankowski cited a CNN report that said that "unemployment hasn't been this low

since Nixon was president," adding that unemployment consistently remains below 4 per cent. He said that only three presidents have had extended periods of such low unemployment -- Harry S Truman (35 months), Richard Nixon (27 months) and Joe Biden (24

months). Consumer confidence appears to be increasing as inflation fears start to ease, Jankowski said. He quoted the Wall Street Journal's survey of forecasters, which predicts that inflation in 2024 will be about 2.4 per cent. High interest rates, especially for 30-year fixed rate mortgages, remain a concern, and Jankowski said that they won't drop any time soon. Home ownership may become more difficult, as the percentage of households able to afford a mortgage continues to fall. In 2021, according to data

Katy real estate: Turning small business owners into real estate tycoons

The number one question I'm asked for the last 18 years: Why Katy?

My answer is simple - Visionary Real Estate Developers

Master-planned residential community developers delivered first -- creating nationally awarded communities like Green Trails, Cinco Ranch, Grand Lakes, and Seven Meadows. Next largescale commercial developers captained Katy projects like La Centerra and the upcoming Katy Boardwalk.

As a practice, most commercial developers craft projects for large-scale national users designed to feed the rental market. The Katy area, like most current markets, offers abundant rental space in what some call a soft rental market. The nearby West Houston Energy Corridor currently has a 20.5% vacancy rate for office space and some aggressive pricing. The Katy Grand Parkway continues to perform well, offering just a 10.7% vacancy rate.

However, what makes Katy special is not the rental rates, but a rare chance for small business entrepreneurs to own instead of rent commercial real estate. A new breed of developers headlined by the Kilcommins Group, Stead-



fast Interests, and Sheevaam Properties tailor properties for an assortment of small businesses, investors, and start-ups to own.

from the Houston Association of Realtors, 58 percent of Houston households could afford the median mortgage; in 202e, only 35 per cent could.

Commercial banks continue to tighten lending standards to both small and large firms, as shown by data from the Federal Reserve System.

Retailers, long bedeviled by pandemic-created supply chain issues, often over-ordered when goods were available and were carrying excess inventory, Jankowski said. That excess inventory has now been cleaned up and retailers are now ordering less -- impacting manufacturing, which is now receiving fewer orders for goods and facing a decline in employment.

For 2024 nationally, Jankowski pre-

- Tight labor markets. Jankowski said that Bureau of Labor Statistics data shows that job openings were 6.4 million before the pandemic and are projected to be 9.0 million this year. The number of people quitting their jobs is also falling, he said.
- "Stubborn interest rates." Because of the Fed's dual mandate to maintain maximum employment and price stability, they are in no hurry to cut interest rates, Jankowski said.
- Inflation will remain at about 2 per cent, according to the U.S. Bureau of Economic Analysis, which studied core personal consumption expenditures adjusted for inflation, he said.
- Real estate will be thrown into turmoil, particularly commercial real estate. Jankowski quoted stats from Bloomberg showing commercial property distress at a ten-year high and said that it is very difficult to get a commercial real estate loan. He said that commercial landlords are even handing properties back to lenders.

Locally, what happens in the Houston area in 2024 depends on the industry,

Jankowski said.

- Net in-migration the number of people moving to the greater Houston area, remains strong - at 85,044 in 2022 according to U.S. Census records.
- Education, retail, entertainment, bars and restaurants will do well as a result of new people moving in.
- Births are expected to exceed 94,000 - driving the need for more healthcare and more healthcare jobs.
- As the population ages with over 32,000 people turning 65 each year additional demand for healthcare will be
- · Oil and gas will remain relatively stable, with few new jobs being created. Production will continue to become more efficient, he said, citing statistics showing high U.S. production from fewer oil rigs.
- There will be growth in demand for professional services (law, accounting) as oil company mergers continue. Mergers almost always result in headquarters being moved to the Houston area, he
- The future also looks bright for manufacturing, wholesale trade and transportation, along with hotels, and bars.
- Office construction will be weak and industrial construction will also fall.
- New home construction is expected to rise slightly to 37,200 starts, up from 36,900 in 2023.
- · Construction, finance, insurance and real estate will plunge in 2024.
- Information companies, such as traditional media outlets, will also suffer
- Projected job growth will be 57,600 jobs in 2024, according to the Texas Workforce Commission and research by the Greater Houston Partnership.

Jankowski concluded his remarks with the reminder that the Houston economy is more like a marathon than a sprint.

policy listed concerns including respect for the Katy community's diverse cultural and religious backgrounds; that chaplains are not certified or licensed and that their training centers on working with adults rather than children; that the program would take away badly needed funding for safety and security measures such as armed officers at each campus; that LBGTQ+ students would be harmed by potential "conversion therapy;" and that the district would be exposed to potential legal risk, as well as other concerns. The lone supporter stated that the policy was meant to be broad and that the board and KISD administration could define and implement the policy to address chaplain selection and certification and other procedural concerns.

Board President Victor Perez opened the trustees' discussion, noting that the board would vote on the issue in the next board meeting on February 26th. He clarified that "no one is talking about replacing school counselors with chaplains." Perez said that the school district is there to educate students and that such a policy would "cross a boundary" into the role of churches and parents. He also expressed concerns that the program does not allow the district to pick and choose who can apply, and that it does not define what a chaplain is nor does it require any licensing or training. Perez added that he did not want to take away from the district's limited resources to pay chaplains. He listed other opportunities for chaplains to volunteer at the district, including Men of Honor, the KEYS mentoring program and Watchdog Dads.

Board Secretary Dawn Champagne cited a letter written and signed by over 100 chaplains (a number she said has since grown to over 400) opposing the policy. Trustee Lance Redmon said that he did not want to have the chaplain program for children but recommended that a chaplain program be created for the well-being of district employees, on an adult-to-adult

Vice President Amy Thieme said that she supported the policy as a way to help prevent teen suicide and teen pregnancy and that she did not want to turn down free resources. "I'm for trying something," she said, also expressing support for a chaplain program for teachers and employees. Trustee Morgan Calhoun clarified that under the chaplain program, no child would be compelled to see a chaplain, and felt that the program would be helpful in dealing with students feeling isolated or contemplating suicide. Although funding for the program would come out of the district's safety and security budget, Calhoun said that there are grants and funds available which would help pay for it.

Champagne expressed concern that the program removes parental rights. You are not at the school when they are talking to the chaplain," she said. Trustee Mary Ellen Cuzela agreed that "parental authority is paramount" and added her concerns that the program does not define the role of chaplain or require certification. "Every creed would have to be allowed and there are some harmful creeds out there that I have learned about," she said.

Trustee Rebecca Fox, after noting her concerns about the policy's lack of restrictions and the lack of an exclusion against proselytizing, asked Perez to read the recommended resolution into the record in order to share it with the public prior to the February 26th vote. Perez did so, and said that essentially the proposed resolution to be voted on next week declines to accept the policy allowing chaplains, and maintains the status quo at Katy ISD. The resolution, if approved, would also allow the board to retain the right to reverse its decision in the future.

The next meeting of the Board of Trustees is Monday, February 26th.

Katy Christian Ministries announces launch of 'Worship Health' benefits plan

On February 20th, Katy Christian Ministries Executive Director Deysi Crespo announced the launch of a new initiative designed to make affordable health care more accessible to the Katy community. The announcement was made at the nonprofit's office at 3506 Porter Road in Katy.

Called "Worship Health," the program -- which is a "benefits plan" and not an insurance plan - provides access to health care for the uninsured and underserved members of the community, Crespo said. The plan can also be used by those who already have insurance but who may be facing high

"Affordable access to health care is one of the key social determinants of health," Crespo said.

The program has been developed in partnership with Shawn Fry, CEO and Data Scientist of OptimalMD Technologies, LLC, which is based in Katy at 154 Bella Katy Road, Suite 200, Katy. Worship Health is part of OptimalMD, which Fry said is a trailblazer in healthcare innovation where the power of telemedicine is blended with first principles functional medicine to deliver an Optimal Standard of Care.

Tennyson Smith of Vital 2 Life Ministries serves as an adviser to the

project. "At Worship Health, every family has the freedom to stay healthy without the complexities of traditional insurance," Fry said. "Plans from \$49 per month provide you with 24/7 access to physicians and the drugs you need to stay healthy WITHOUT traditional

obstacles such as deductibles, co-pays, prior authorizations and denials."

Because the plan is a "benefits" plan and not a traditional insurance plan, it is focused on providing primary care, and it doesn't cover certain other services such as MRIs, X-rays and so forth. "Our program covers 95% of the typical medical encounters per year," said Fry. "Most people go to the doctor or emergency room when they don't need to. It does make people feel better when their kid is sick, and if they are sick (turning blue, can't breathe, fever of 103, etc., they should go." What is included in Worship Health, according to Fry, is 24/7 access to a doctor via telemedicine and discounted access to the rest. of things. "We have detailed case studies that show 95% of incidents are covered by this program," said Fry. "It also shows this program radically reduces the number of more serious cases because people get care much earlier in the process. Most major issues come from not treating issues before they get severe."

Surgeries, chemotherapy and similar follow up procedures are not covered. "If your income is in certain ranges. you get free or deeply discounted services." said Fry. "If your income is ABOVE their thresholds, [and] if you get cancer, we would enroll you in an Exchange plan that covers your condition."

Acceptance into the Worship Health program is guaranteed, Fry said. "We promise everyone is approved regardless of illness, age, immigration status, income or any other reason. Get the healthcare you deserve without the cost and hassle from insurance companies."

The plan includes virtual visits with

health care providers, pharmacy benefits and mental health counseling. Fry said that over-the-counter (OTC) drugs were also available at reduced cost through this program and that other drugs, such as ADD meds, ED meds and birth control, could be obtained through the program.

Aging parents are one of the greatest challenges that families face today, Fry said. The program allows parents and in-laws to be added to a family's plan for just \$10.00 each per month.

The program is ideal for small business owners who may not be able to offer affordable health care options to their employees, Fry said.

The program is already live and accepting members, Fry said. Only a full name and email address are required in order to sign up, he continued. The program is month-to-month and does not require a long-term contract or agreement. Unlike conventional employer-provided insurance plans, the Worship Health plan is portable, staying with the enrollee in spite of job changes or other circumstances. Data is secure and private and not reported to insurance companies or anyone else, Fry said.

Crespo said that information on the Worship Health plan would be distributed to KCM's clients through the food pantry distribution, through the crisis center and through the nonprofit's social services department. Representatives from Worship Health will be at the Porter Road office of KCM on Tuesdays and Thursdays to help people get registered and to answer questions, Crespo said.



Jordan finished the regular season on a fourgame winning streak while Katy won its final three games of the regular season. Jordan claimed the tiebreaking game win last weekend win by beating Katy 63-44 to clinch the third seed, while Katy fell to the fourth seed with
