Notice by Publication of an Amendment of an Existing Permit
Enstor Katy Storage and Transportation, L.P. (10375 Richmond Ave., Houston, TX 77042) is applying to the Railroad Commission of Texas for an amendment to an existing gas storage reservoir permit. The applicant is storing natural gas in the Yegua Formation, Fulshear (Hillebrenner) Field, KST Katy Lease, amending Well Nos. 3, 8A, and 12. The Facility is located 2 miles in the southeast direction from Katy, in the Fulshear (Hillebrenner) Field, in Fort Bend County. The gas storage reservoir is located in the subsurface depth interval from 6872 feet to 7699 feet. The request in this application is to amend the permit removing the temporary exceptions granted grated by the RRC on Well Nos. 8A and 12. The temporary exceptions were granted regarding minimum packer depths on the referenced Injection wells. With the amended permit, the No. 8A well will be reclassified as an Observation well. The packer on the No. 12 well was lowered during a workover and now complies with the packer depth restrictions in the original permit. Enstor is not seeking to increase the size of the gas storage facility or to change the location of any surface facilities. A copy of all materials submitted by the applicant is available for public inspection at the Railroad Commission of Texas office at 1701 N. Congress Ave., Austin, Texas 78701.

LEGAL AUTHORITY: Chapter 27 of the Texas Water Code, as amended, Title 3 of the Texas Natural Resources Code, as amended, and the Statewide Rules of the Oil and Gas Division of the Railroad Commission of Texas.

Persons who can show they may be adversely affected by the amended existing gas storage reservoir may request a public hearing on the application. Such request must be received in writing within fifteen days of the last date of publication of this notice. All bids will be publicly opened and read aloud for construction of improvements including irrigation, planting, fine grading, hydromulch, and solid sod.
