# **PAC takes aim at 3 KISD trustee candidates**



The Houston-based Texans for Education Freedom political action committee has mailed fliers to Katy ISD residents urging support for candidates Amy Thieme, Morgan Calhoun and Mary Ellen Cuzela.



The latest third such flier, being received by voters this week, attacks candidates Bruce Bradford, Cicely Taylor and Shana Peterson as being the "far-left" choices for the school board

The Katy ISD Board of Trustees race has become personal, with a PAC-funded political flyer attacking three candidates and comparing them to President Biden and former Texas Democratic gubernatorial candidate Beto O'Rourke.

'Bruce Bradford, Cicely Taylor, and Shana Peterson: The far-left choices for the Katy ISD school board?" the flyer said. "There's no way we can trust Bradford, Taylor and Peterson to keep

radical ideologies out of Katy classrooms."

The Austin-based Texans for Educational Freedom PAC sent the flyer. In addition to attacking Bradford, Taylor and Peterson, the flyer endorses the slate of Amy Thieme, Morgan Calhoun and Mary Ellen Cuzela.

The PAC—or political action committee-has endorsed candidates in two other Houston-area districts, Clear Creek ISD and Spring Branch ISD, as well as other districts across the state.

# Trustee candidates file finance reports

Seven of eight candidates for the Katy ISD Board of Trustees filed their campaign finance reports April 28, with the reports showing that four candidates received either political action committee funds or in-kind services.

Shawn Miller, a college professor seeking position 3, did not file a report. The other two position 3 candidates — Bruce Bradford, a mortgage loan originator, and Amy Thieme, a realtor — filed reports.

The three position 4 candidates-Erica Brettell, a stav-athome mom; Morgan Calhoun, a stay-at-home mom; and Cicely Taylor, an education administrator—filed reports.

The two position 5 candidates Mary Ellen Cuzela, a Katy ISD substitute teacher, and Shana Peterson, who is retired - filed reports. Of the four candidates receiving help from political action committees, or PACs, three are receiving in-kind services from Texans for Educational Freedom, which is based in Austin. Texans for Educational Freedom filed a report with the Texas Ethics Commission detailing its contributions to Thieme, Calhoun and Cuzela. According

Pattison puts its brand on things as it celebrates its ranching heritage

Waller County this month is celebrating its sesquicentennial-its 150th birthday- with festivities scheduled throughout the county. Even Katy, a part of which is in Waller County, will host local festivities this week.

But leave it to Pattison to leave its own, unique mark on things. Actually, many unique marks. The Pattison community held a branding party May 1 at the Pattison United Methodist Church, 3711 Ave. H in Pattison. There, a group led by Kurt Klausmeyer-he's been branding cattle for 35 years—heated up branding irons from area ranches. They made their mark, so to speak, on some boards that are expected to hang in a new Waller County Courthouse now being planned in

Hempstead. Many brands have historical ties to the area. One longtime area rancher, Danny Lang, Jr., traced his family's Texas ties to July, 1824, when Stephen F. Austin brought the first Anglo settlers to Texas, then a part of Mexico. They settled in San Felipe, which is about nine miles west of Pattison on FM 1458. His family ranch brand, the bar 7C(7C, with a bar above it), is on the branding board. The C

"We seek to implement thoughtful solutions through data-driven, evidence-based, and equitable project prioritization,"

Briones said. "The result will be a stronger future for the next generation-my three daughters, and all children-in Harris County."

Eligible applicants include cities, school districts, Municipal Utility Districts (MUDs), Tax Increment Reinvestment Zones (TIRZs), Municipal Management Districts (MMDs), Public Transit Agencies, Economic Development Corporations (EDCs), housing authorities, and other local government corporations.

Funding applications will be considered for projects between \$350,000 and \$20 million. The deadline to submit applications

is June 16.

"We are looking for projects that are in line with values like equity, sustainability, and resiliency," Reynaldo Guerra, chief of infrastructure, said. "We want to ensure all communities across Precinct 4 are receiving infrastructure investments in accordance with their needs. Projects must be adapted to the new climate and economic challenges we're facing in the 21st century and must also have community support and





to this report, the PAC spent \$4,875 in advertising expenses for each candidate. Three payments of \$1,625 were made on April 8, April 10 and April 12 with Axiom Strategies of Kansas City, Mo., for advertising expenses.

According to its texansforeducationalfreedom.com website, the PAC mission "has the sole purpose of electing freedom-minded officials to school boards to ensure the liberties of our citizens."

Yet while Texans for Educational Freedom made and reported the contributions, they were not listed on Thieme, Calhoun or Cuzela's reports.

Meanwhile, Taylor reported that she received a \$2,000 donation from leadership for educational

equity, of Washington, D. C. According to its educationalequity.org website, LEE (as it is known) is a "nonprofit leadership development organization inspiring & supporting a network of civic leaders to end the injustice of educational inequity.

Some candidates are receiving support from incumbent trustees. Trustees Victor Perez and Dawn Champagne have endorsed Thieme, Calhoun and Cuzela. Trustee Ashley Vann has contributed \$200 to both the Bradford and Peterson campaigns.

Vann holds the position 3 seat. She chose not to seek re-election, as did her two fellow incumbents, position 4 trustee Leah Wilson and position 5 trustee Greg Shulte. This year's election is the first in recent memory in which no incumbent sought re-election.

Bradford reported \$1,400 in contributions and \$3,708.80 in expenditures. Thieme reported \$1,280

in contributions and \$1,905.87 in expenditures. Brettell reported \$1, 602 in contributions and \$1,506.49 in expenditures. Calhoun reported \$680 in

contributions and \$2,913.51 in expenditures. Taylor reported \$3,100 in

contributions and \$2,358 in expenditures.

Cuzela reported \$1,678.27 in contributions and \$1,882.77 in expenditures

Peterson reported \$500 in contributions \$2,363.29 in expenditures. Early voting ended May

Lang said his family's ties to the area were such that the City of Brookshire might have been named Cooper had there not already been a post office named Cooper. But Brookshire got its name from Nathen Brookshire, who was part of Austin's fifth colony in 1835, according to the Texas State Historical Association.

Brands can be changed as times change and new generations take over ranching operations. One rancher, Tom Paben, who lives and works near Monaville, pointed to a group of brands that his family has used over the years. The one his family uses now, he said, has his initials, TLP.

His father's side of the family is a relative newcomer to the area, he said, coming in 1925 from Nebraska to Texas. Right now, he said, the cattle business in Waller County is doing pretty well.

Peterson, who is retired, is running for position 5 against Cuzela, a Katy ISD substitute teacher.

"I said from the beginning that I was running a clean campaign, and I've kept to that." Peterson said. "This is slander. Maybe they're concerned that I'm winning."

As for the allegation that her views are far to the left, Peterson said she has described herself as a conservative Republican and has been open about that, even with her supporters who are Democrats.

She said this card is the third one she has received, and the first to go negative.

servative," and that he has voted Republican in every presidential election since the late 1970s, when he began voting. Still, he said, he was not going to classify himself by party.

"I wish that people would stay focused on the job at hand for a candidate or board member and that is to serve 93,000-plus children that come from diverse backgrounds," Bradford said. "As a moderate conservative I can talk to people on the left and right, I can communicate and can serve."

Taylor, who is making her second campaign for the board—she lost the position 1 race to Victor Perez last year—said she hasn't seen the card yet, but was aware of it.

"I haven't checked my mailbox," Taylor said. "It

very clear that I'm for all kids, no matter what political interests you have. People can choose to put out what they put out. I won't unfairly characterize any candidates or board members."

It was not immediately clear whether Thieme, Calhoun and Cuzela, who have often campaigned together and have the endorsements of incumbent trustees Victor Perez and Dawn Champagne, endorse the PAC's positions or the attack strategy it has taken. Efforts to reach Thieme, Calhoun and Cuzela for comment by press time were unsuccessful.

Absentee voting began May 24 and ran through May 2. A candidate only needs a plurality of votes to win the election. Election Day is May 6.


Harris Cooper Garrett, 94, of Brookshire, passed away at his home on Thursday, April 27, 2023.




Tompkins and Taylor both fell in the bi-district round of the playoffs, as the two programs' strong seasons came to an end in the first round of the playoffs on Friday.


Katy ISD officially announced its new Athletic Director on Monday, naming Lance Carter to the role of Executive Athletic Director of the District.



Seven Lakes players celebrate after winning Monday's District 19-6A play-in game between Seven Lakes and Taylor at the Mayde Creek baseball field.


# Seven Lakes uses offensive spark to down Taylor, clinch playoff berth


Taylor fell in two games to George Ranch in their series, as they kept things close but were unable to win in 0-5 and 3-5 losses.



# Texans select Stroud, Anderson in NFL Draft

The Texans made a splash in the NFL draft on Thursday, drafting Ohio State quarterback CJ Stroud with the second overall pick in the draft, giving the Texans their quarterback of the future early in the first round.

They followed that up with the move of the draft, trading back up to No. 3 in the draft to take Will Anderson, who is considered the best defensive player in the draft. Giving Houston a cornerstone at defensive end/outside linebacker for years to come.

"Houston is bringing in a leader," Stroud said. "I'm somebody who is going to come in, go to work every day and work their tail off. I come from a winning tradition and I want to win — that's all I care about and I want to help Houston do that."

Stroud was a star at Ohio State over the past two years, being a Heisman Finalist both seasons and leading the Buckeyes to the College Football Playoffs in 2022 and putting up a terrific game against one of the best college defenses in history in the Georgia Bulldogs 2022 defense. He completed nearly 70% of his passes over his collegiate career, throwing for over 8,000 yards in two years and throwing 85 touchdowns to six interceptions with a 182.4 qb rating.

"I just am going to come in and be the best teammate in the draft," Stroud said. "I'm going to be the best leader in the draft too. I'm going to do everything I can for these guys and I'm going to be the best quarterback I can be."

Will Anderson was a beast over his three years at Alabama, garnering 34.5 sacks, 58.5 tackles for loss, 204 tackles and an interception over the course of his time with the program. He helped Alabama to a national championship in 2020 and a national championship game appearance in 2021.

"I'm just so blessed to be put in this position," Anderson said. "These Texans fans are getting a complete player and a complete person. I'm going to be a good player and someone who goes out there, does his job and is relentless. I'm going to have a motor and

every bit of motivation, support my teammates and be jumping up and down. That's what I'm all about, I'm just ready."

The duo will help make up the new core of the Texans, as they try to come back from three down seasons and become a competitive team again.

The trade was a big one but with the amount of draft picks the Texans have, as they entered draft night with 12 picks. Houston gave up the No. 12 overall pick in the draft as well as the 33rd overall pick, while sending a first and third round and 2024 to the Cardinals. The Texans brought back the 104th pick in the draft along with the third.

# Atlanta Falcons draft Texas running back Bijan Robinson

Hopefully they like their mustard extra spicy in Atlanta.

The Atlanta Falcons drafted Texas running back Bijan Robinson with the eighth overall pick in the first round of the 2023 NFL Draft on Thursday night.

"Bijan is a really special player," Texas head coach Steve Sarkisian said. "As I've said all along, he's a better human being than football player, which is hard for a lot of guys when you're that talented."

Robinson is the 45th Texas player to be selected in the first round, and the first since Malcolm Brown was picked with the 32nd pick in 2015. He is the first Longhorns running back to be a first-round pick since Cedric Benson in 2005.

He played in 31 games in his three seasons with Texas, ranking fourth in school history with 3,410 rushing yards and 41 total touchdowns (His 33 rushing touchdowns are third-most in program history).

Robinson has 60 receptions for 805 yards and eight touchdowns,

good for third all-time by a Texas running back.

"He checks all the boxes," Sarkisian said. "The Atlanta Falcons are getting a uniquely versatile player. He can run between the tackles, run outside the tackles, make people miss in tight quarters — he's got great contact balance, is an excellent receiver, and has a high football IQ. You name it, he's got it."

Last season, he ranked fifth nationally in rushing touchdowns (18), all-purpose yards (157.83 ypg) and scoring (10.0 ppg), sixth in rushing yards (1,580) and rushing yards per game (131.7) and eighth in total points scored (120), while leading the Big 12 in each category.

Robinson won the Doak Walker Award for the top running back in college football and was a unanimous All-American selection.

"He'll be an awesome teammate, great in their locker room, tremendous in the community and just someone that they'll be so proud of to have in their organization," Sarkisian said. "We absolutely love him so much here and can't wait to watch him in the NFL."

Things stayed that way until the fifth inning, when Seven Lakes answered back. The Spartans got a run across on a wild pitch before Paden Reynolds drove in a run on a single. Miguel Acosta brought in two more runs with a single and an error allowed yet another run to come across before Tv Berra capped off the inning with a single, driving in another to make it 7-5 Spartans.

"It was probably the sloppiest

Cinco tied the game in the bottom of the fifth, as Logan Sosolik drove in a run on a single and Ranier Castillo tied it when he was hit by a pitch with the bases loaded. The Cougars couldn't get anything more across in the fifth, but they loaded the bases up again in the sixth and Atkinson made Seven Lakes pay by hitting a grand slam, putting the Cougars up by four as they would hold it the rest of the way.

Logan Sosolik earned the win for Cinco Ranch after coming on in relief. He pitched 2.2 innings of scoreless ball, allowing two hits and striking out one.

"We just have guys that will find a way to win and you have to find a way to win in every aspect of the game," Atkinson said. "We were able to do that tonight with our relief pitching and offensively, but we also have to be able to move runners over and play small ball as well. That's just how we continue to win is by doing it in different ways."

The Cougars closed out district play with a win Friday, clinching a share of the District 19-6A championship along with Tompkins.

"It's huge for us," Atkinson said. "Everyone knows what a district championship would mean for us and that's been our goal. But the most important thing for us is to just win the game that's in front of us every day and go 1-0 every time we go out there. We just have to do that same thing on Friday."


