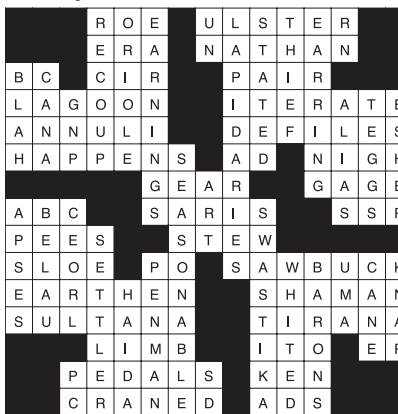

Conner, President, Board of Directors, will be received at City of Katy City Hall, 901 Avenue C, Katy, Texas 77493, **until 2:00 p.m. local time, Thursday, July 27, 2023**, and then publicly opened and read for **"Kingsland Boulevard and Cane Island Parkway Improvements"** for Katy Development Authority, of Harris County, Texas.

Scope of Work of the Contract includes the construction of the additional lanes to complete the boulevard section of north side of Kingsland Boulevard. The total roadway length is approximately 1,200 linear feet. The project involves completing the boulevard section by constructing the other two travel lanes, associated turn lanes, median cuts and installation of drainage inlets. The project also includes modifications to the existing traffic signal at the Kingsland Boulevard and Cane Island Parkway intersection, additional curbs ramps and crosswalks, as well as constructing westbound travel lanes on Kingsland Boulevard.
