School board approves boundary modifications

Katy ISD board also hears updates on financial rating system and literacy goals

During Monday's regular Board Meeting, the Katy ISD Board of Trustees voted to approve an attendance boundary modification (ABM) for two of the district's future schools -- Junior High #18 and High School #10 -- as well as areas served by Haskett Junior High, Stockdick Junior High, Paetow High School, and Katy High School. This ABM would address the rapid growth within the neighborhoods surrounding those campuses. The new ABM will go into effect for the 2024-2025 academic year.

Katy ISD annually reviews its attendance boundaries to ensure the district is adequately addressing its fast growth, as well as student and staff capacity at schools. The district surveyed the families who were identified as potentially impacted by the boundary modifications.

Currently, the northwest quadrant of Katy ISD is experiencing increased growth due to several new housing developments and

businesses coming to the area. Both Junior High #18 and High School #10 are located in this quadrant and are scheduled to open in the fall of 2024.

Christopher J. Smith, Chief Financial Officer at Katy ISD announced that the district has achieved an exemplary "A" rating for "Superior Achievement" in the Texas Schools FIRST (Financial Integrity Rating System of Texas). The district has earned this distinction for 21 consecutive years.

The FIRST rating signifies the district's dedication to transparent, efficient, and accountable financial practices. In this year's evaluation, Katy ISD excelled by meeting all critical indicators and amassing an impressive 98-point score in the

KAEDC celebrates groundbreaking for new medical office building

Katy Area Economic Development Council President and CEO Angie Thomason opened the ceremonies for the groundbreaking of a new medical office building near the intersection of SH 99 and I-10. The event took place Thursday, October 12th at 130 Bella Katy Drive in Katy.

The Scott Square Medical Office Building project will be a three-story, tilt wall structure with over 25,000 square feet of medical office space and it is expected to be completed in October 2024, Thomason said. The development comes from a team of five Katy-area doctors, including Dr. Nimish Dave and Dr. Karan Madan of Katy Pain & Spine. Katy Pain & Spine, which has been serving the community for over eight years, will be opening a second office in Scott Square on the second floor. An ambulatory surgery center and pain management center will be opening on the third floor, and the first floor currently has 8,700

square feet of space available for lease. "The available space could be ideal for a radiology office to provide imaging services, a pharmacy, or other medical offices," Thomason said.

Harris County Precinct 4 Community Engagement Coordinator Maida Guillen also welcomed the new facility. Other dignitaries in attendance included Katy Mayor Dusty Thiele and

Katy Mayor Pro Tem Chris Harris.

"We are proud to continue our investment in the community," said Dr. Dave.

Fort Bend County officials outline priorities for growth

Officials address misleading information concerning the mobility and parks bonds

Fort Bend County Judge KP George held a press conference on October 19th to express the proactive steps that he and County Commissioners are taking to address the growing needs of the eighth-largest county in Texas. The proposed Mobility and Parks Bonds are set to play a pivotal role in accommodating the

changing landscape and enhancing the quality of life for residents, according to a press release.

George, along with Fort Bend County Engineer Stacy Slawinski, Fort Bend County Auditor Ed Sturdivant, and Fort Bend County Parks Director Darren McCarthy, spoke about the importance of the Mobility and Parks

Waller County hosts final town hall on mobility bond

Earlier this year, Waller County Commissioners
Court authorized a mobility needs assessment, with the goal of identifying short and long-term needs. As the study concluded, and the results were presented, the Court decided to bring to the voters a \$280 million bond proposition with 25 proposed projects, which were all identified in the study.

The Court has been hosting town hall meetings every Thursday in October to discuss the bond proposition with the public. County Judge Trey Duhon and Commissioner Justin Beckendorff hosted the last of four town hall meetings on October 26th at the Waller County Courthouse Annex at 32225 Hwy 90 in Brookshire, regarding the 2023 mobility bond proposition.

The meeting focused on the reasons that the Court

decided to bring a bond proposition to the public. Judge Duhon said that back in the 40s and 50s, the Commissioners Court paved a large amount of roadways, and today there is about 550 miles of county maintained paved roads, which are need of repair, extension, expansion, and safety improvements. The county is also seeing a large amount of growth, and with the growth comes more cars, Duhon said. Traffic was discussed at the meeting and Judge Duhon and Commissioner Beckendorff said that the county population is expected to double by the end of the decade.

Residents attending the meeting asked questions on how long it would take to pay off the debt, how it would impact their taxes, and asked for clarification on the projects presented. County officials said that the county has 20 years to pay off the debt.

Commissioner Briones highlights success of Domestic Violence Assistance Fund

In recognition of Domestic Violence Awareness Month, Harris County Precinct 4 Commissioner Lesley Briones held a press conference in downtown Houston on Friday, October 27th, highlighting the critical work of the Harris County Domestic Violence Coordinating Council and the 19 nonprofit groups awarded grants through the Domestic Violence Assistance Fund (DVAF).

Katy Christian Ministries, represented by Executive Director Deysi Crespo, was among the groups recognized. In 2020, spurred by the alarming increase of intimate partner violence and the lack of access to safety for survivors during the COVID-19 pandemic, Commissioners Court created the Domestic Violence Assistance Fund allocating an initial \$1 million from the federal CARES Act Response and Recovery fund. Last October, Commissioners approved an additional \$4.7 million in federal American Rescue Plan Act funding for the DVAF through 2024.

Administered by the Harris County Domestic Violence Coordinating Council (HCDVCC), the fund provides immediate financial relief to survivors. In March 2023, HCDVCC distributed grants of

Local organizations support victims of domestic violence

In a somber, moving ceremony held Thursday night at Westland Baptist Church, the staff of Katy Christian Ministries' Crisis Center remembered and honored more than 50 victims of domestic violence from the Harris County area at the annual "Silent Witness" event.

Each victim's name was read aloud as a white rose was placed in a vase in remembrance of each life lost. Victims included males and females and spanned all age groups and many different ethnicities.

Around the room, each victim was represented by a red silhouette bearing their name. The Silent Witness Project consists of a travelling exhibit of these life-sized red wooden silhouettes - each of which stands for a person who was murdered by their intimate partners and/or family member.

"The mission of this project is to remind us of the impact of domestic homicides and family violence within our communities," according to the event program. "Because the victims no longer have a voice, the silhouettes are called Silent Witnesses."

Sarah Nejdl, who was honored during the evening with KCM's Brittany Whalen Ramsey Award, said that more than 24% of all domestic violence victims in Texas were killed in Harris County in 2022. Nejdl is the founder of Families to Freedom, a nonprofit group which provides transportation for victims and families fleeing domestic violence.

KCM's Crisis Center provides emergency crisis intervention and advocacy for victims of domestic and sexual abuse. Services include safety planning, a 24/7 Hotline, therapy services, shelter placements, support groups, assistance with

Crime Victims Compensation, protective orders, Texas VINE, and more.

American Legion Women's Auxiliary collects donations for victims of domestic violence

The American Legion Women's Auxiliary collected over 75 pairs of Pajama's for women and children in support of Domestic Awareness Month during October, said Linda Malsbary, president ALA Unit 164. The organization partnered with the office of Harris County Constable Ted Heap Precinct 5 and their coordinator Barbara McInnis.

process, district officials said. The Texas Schools FIRST program, established in response to Senate Bill 875 of the 76th Texas Legislature in 1999 and amended under House Bill 5 of the 83rd Texas Legislature, is a financial accountability system for Texas school districts. Its primary goal is to ensure that school districts excel in managing their financial resources.

"Katy ISD has grown exponentially since the inception of the Texas Schools FIRST rating. To consistently earn a 'Superior Achievement' rating every year while experiencing tremendous growth across the district is something we are especially proud of," said Smith. "This accomplishment signifies that our district is not only dedicated to student learning but is also adept at achieving these results cost-effectively and efficiently, making the most of our taxpayers' hard-earned dollars."

'Our county is a great place to live and work, and that's no secret. As we continue to attract businesses and residents, we want to ensure that we maintain the quality of life our residents are accustomed to and attract industry to our region. That's why these proposed bonds, will help us address the needs of our growing community," said George.

On November 7, Fort Bend County residents will head to the polls to cast their votes on the \$865 million Mobility and Parks Bond. The Bond proposal contains 98 projects, which include a Mobility Bond, valued at \$712 million, and the Parks Bond, totaling \$153 million.

The Mobility Bond will focus on improving the transportation infrastructure, including road maintenance, and new road construction. With this bond, Fort Bend County aims to reduce traffic congestion, enhance safety, and make commuting more efficient for residents.

County Engineer Stacy Slawinski noted that there are 70 new roadway projects and over 20 projects that are traffic and pedestrian improvement projects. Additionally, Slawinski highlighted the FM 2759 project

from FM 762 to the city of Thompsons, stating that the current asphalt road will connect to the future Bridge when the Fort Bend Toll Road is extended over the Brazos River. The bridge will bring a significant amount of traffic to Thompsons, so the FM 2759 project is necessary to take on the higher demand.

The Parks Bond will prioritize the development and enhancement of parks, recreational facilities, and open spaces. Some of the projects include creating a safe crossover from Freedom Park in Precinct 1 across Westheimer Parkway, constructing a senior center in Precinct 2 in Rosenberg, in Precinct 3 building a splash pad and cricket field in Sta-Mo Park, and re-opening the T.W. Davis WMCA in Precinct 4.

During the press conference, George took the opportunity to address what he called "the misleading and distorted messages that have been circulating within the community regarding the Mobility and Parks Bonds," highlighting that it is important for residents to rely on accurate sources of information and to be aware of deceptive tactics aimed at misleading the public.

George urged residents to visit the County's website at [fbctx.gov]FBCTX.gov for more information on the Bond proposals.





"We are very happy to announce that yesterday Katy's First Baptist called Dr. Rob Lyerly be our new Senior Pastor," said Baldwin. "Dr. Lyerly (Pastor Rob) grew up in South Carolina and felt the call to be a pastor while playing professional baseball. Pastor Rob is committed to preaching the Gospel each week and doing his best to shepherd God's church at Katy's First."

The congregation was founded in 1898, three years after the townsite of Katy was laid out and platted by J. O. Thomas, according to "Preserving the Vision: The First 100 Years of the First Baptist Church of Katy." The book, published in 1998 by the historical subcommittee of the centennial committee of the church, chronicles the first 100 years of the church's history.

According to the book, a union Sunday school had been organized as early as 1895 or as late as 1898 - called "union" because it welcomed all denominations. Quakers, Presbyterians, Methodists, Baptists and others met together, and the Baptist and Methodist groups were responsible for the services, which were conducted on alternate Sundays. Although the Baptists organized in 1898 under the name "Zion Baptist Church," they had no building of their own and they began meeting in the local schoolhouse located at Avenue A and Sixth Street. After the 1900 storm destroyed the schoolhouse, services were hold in the Featherston and Morrison homes until the schoolhouse was rebuilt in 1901, and then in the Methodist Church after that building was completed in 1904. In 1907 the church voted to change its name to the Katy First Baptist Church. In April 1914 the Baptist church moved into their very own unfurnished building (built at a cost of \$1,380.00) and organized a Baptist Sunday school.

During the twenties and thirties, the church grew steadily under the leadership of short-term pastors, most of who were half-time seminary students who served for \$50.00 per month. During the pastorate of the Reverend N. Ray Harrel from 1936 to 1938, a two-story annex of classrooms was added to the church building and in 1936 the church purchased hymnals for use in its worship services. In 1939, the church spent \$1850.00 to purchase its first parsonage, a two-story frame building adjacent to the church at the

corner of East Avenue and Third Street.

The first Vacation Bible School was conducted in the summer of 1941. But World War II brought change. The church continued its missionary efforts, taking up a special offering to send Bibles to the Russians. The Humble Katy Gas Plant went into operation in 1943 to provide wartime gasoline, bringing many newcomers to Katy. Through the encouragement of church leadership, many of these "outsiders" became new members and leaders in Katy Baptist Church. In 1946, the church voted to build a larger auditorium and educational space. In 1948, the name First Baptist Church of Katy was chosen by the members.

Continued growth in membership required additional expansion in the church plant and facilities and a parking lot was added in 1950 and an electric organ was purchased in 1953. In 1958 a new four-bedroom brick parsonage on East Avenue was built at a cost of \$27,280.00 and the old parsonage was sold for \$1000.00. In 1963 the church faced the difficult decision of building a new larger Worship Center or starting a new mission. The Katy Bible Church was formed as a result of this experience.

In June of 1974, the past practices of the pioneers were revisited, as the Baptist Church held a special evangelistic service at the Katy Methodist Church on Sunday night. The church met with all other denominations in the FVW Park for Sunday evening services on September 6, 1976.

In the spring of 1977, First Baptist Church of Katy began a Spanish Language Mission. This ministry evolved into a self-supporting church as the Primera Iglesia Bautista de Katy on Highway Boulevard. In 1986 a missionary effort resulted in the self-supporting church, Primera Iglesia Bautista de

• New Vision Baptist Church (Katy) in 1997 A building committee was formed in

1980 and affirmed the membership's desire to build a two-story Chistian Life Center, remodel the Worship Center, refurbish the older buildings, convert the fellowship hall into a chapel, and expand the office area to include a new pastor's office. But space continued to be a problem and five portable buildings were purchased in 1981.

In 1985 a Long Range Planning Committee was reactivated and it struggled with the concept of relocation. In 1986 the committee presented a motion to find land for the church, which was overwhelmingly adopted. The church found 20 acres on Pin Oak Road at Roberts Street, which was purchased in 1993 for \$450,000.00 and dedicated in 1994. A one campus relocation was approved in 1997.

In 1998, the church celebrated its 100th birthday. The new vision statement said, in part: "We will be intentionally involved in

the lives of people in a changing metropolitan Katy who are in need of God's restoration by focusing on large group worship, small group Bible study and need-based ministries."

The church's current ministries are:

The church also includes the following among its missions, according to the church website:

Now with a membership of 366, the church faces new challenges as it looks toward its next 125 years.

"The biggest challenge facing the church

in Katy today is living and ministering in an American culture that is growing more hostile to biblical truth," Baldwin said. "While opposition to the gospel is not rare in church history, we must be aware that the dynamic of our era has changed over the last few decades."

"The next 25 years are solely in the Lord's hands," Baldwin continued. "But, we will strive, by His grace, to be faithful in every capacity. We will endeavor to remain steadfast on the unchanging standard of Scripture, be zealous in love and good works, and live each day for God's glory."

Also noted by the College Board, schools on the AP School Honor Roll may also earn the AP Access Award. Schools earn the additional award if the percentage of AP Exam takers who are underrepresented minority and/ or low-income students mirrors the school's overall student demographics.

a 48-yard touchdown, but Sample took the ensuing kickoff back 95-yards for a touchdown to get the Warriors right back into it. Jordan's defense came up with a stop after that and the offense turned the opportunity into points after driving down the field with Willetts throwing a 7-yard score to Andrew Marsh to tie it, but Tompkins responded with a score just 30 seconds before halftime as Young threw a 2-yard touchdown pass to Adebisi Bello, putting the Falcons up 28-21 at halftime.

Tompkins came out with a concerted effort to pound the ball in the run game on offense and control the tempo and clock, keeping the ball away from the explosive Jordan offense. It paid dividends as it kept the defense fresh and it was that unit that made a couple of key stops in the second half.

'It was huge for us to keep control of the clock and run time as an offense," said senior offensive lineman Ashton Funk. "They have a lot of good players on their offense so any time you can keep it away from them it's a win. We just wanted to make sure we got everything out of every play."

The first of those stops came right at the beginning of the half. Jordan moved the ball well on its first drive and got to the 4-yard line for a first and goal, but the Falcons pushed them backwards three straight plays and forced a field goal. The Falcons' offense came back with a strong drive and even when Young had to go to the sideline with a small injury, his backup Justin Thierheimer came in and made an impact throwing a 23yard touchdown to Rhys Phillips. The Falcons made a defensive stop after, but the Warriors' defense

came up with a big play in turn, forcing a fumble at their own 1-yard line and recovering it in their own endzone early in the fourth quarter to keep their chances alive. But the Tompkins defense made a stop of its own on the next drive, forcing Jordan into a fourth and extremely long and then a turnover on downs. Young scored on a 29-yard touchdown to make things even harder for the Warriors and then Tompkins did a surprise onside kick, getting the ball back with Young capping things off with another touchdown, a 33-yard run.

Young finished the game with 231 yards rushing and three rushing touchdowns, adding 61 yards through the air and a passing touchdown. Blocker ran for 208 yards and two scores and caught two passes for 25 yards while the Falcons rushed for 487 yards as a team.

"Our offensive line is the center of us - they are the central part of everything we do on offense," Young said. "I can't say enough about them. They control the ine of scrimmage the whole game, they let the guys in the backfield get shifty and open things up for us. I give those guys all the credit because they block everything up perfectly and that is the start of everything.

Tompkins will close out the regular season with a game against Paetow before heading into the playoffs. In all likelihood the Falcons will be the second seed out of Division I in the playoffs.

"We had our bumps at the beginning of the season, but guys are starting to reach their full potential and it's exciting," Davis said. "Everyone here just goes out there and plays hard and as long as we keep doing that we are going to keep getting better."

Taylor started the game with the ball but Paetow made an interception by Jaeden Spelmon to set themselves up in good field position early. Taylor though, made a play right back with an interception of its own by Victory Kalu-Uka and drove down the field before having to settle for a 28-yard field goal converted by Jackson Waller. The Taylor defense continued to make big plays and after another stop the Mustangs scored a touchdown on a 30-yard pass from Daniel Bruns to Jeremy McCullough. The Panthers made two big interceptions after that though — Carmelo Brooks made the first and after the Taylor defense kept Paetow's offense off the board. Jamaal Comminie made an interception and returned it inside the Mustangs five yard line, which the Paetow offense converted into six on a 2-yard pass by Jackson Farrar to Jabari Bush late in the second half, as Taylor took a 10-6 lead into halftime, with both defenses playing very strong.

"This defense, we all just play for each other," Comminie said. "We just stuck to our keys and played our role. We're a defense with attitude and we are always going to play hard. We wanted to win for everyone in this program — the players and the coaches — and it was a great feeling to get this one."

Both teams continued the defensive battle in the second half as neither were able to get on the board. That continued late into the fourth quarter, when the Paetow offense came alive. The Panthers took a drive from deep in their own territory and drove the length of the field and scoring on a fourth and goal from the two vard line on a Kaleb Molina run with 3:37 remaining. Taylor had a chance to get down the field and win it, but the Panthers forced a turnover on downs to end the game and secure their second straight win.

Kaleb is one of the hardest working kids I know, and when kids like that get rewarded, it's awesome," Hicks said. "He does everything the right way and is a great kid. I'm so proud of that guy and happy he got that moment. He made some big time plays tonight."

Paetow will end its season with a game against Tompkins and will look to extend the win streak to three games.

"This is great and I'm so happy right now, but we want another one," Molina said. "This was a good week but now we have to turn the page to next week, keep the momentum going and get another win. This is our last game and we want to go out the right way."





TEXAS LEGISLATURE DESIGNATES NOVEMBER 3RD AS TEXAS HIGH SCHOOL COACHES DAY

Texas High School Coaches Association and school communities plan celebrations of Texas coaches.

San Marcos, Texas (October 16, 2023) – High school and middle school coaches all over Texas now have a day specifically designated to celebrate their positive impact on students and communities. Student-athletes learn time management skills, leadership skills, the value of hard work, teamwork, and how to work through adversity. An article published by the National Federation of High Schools outlines that students also show a "stronger sense of self-confidence in building relationships with others and having an expanded capacity for empathy." Additionally, studies like those published in the Medicine & Science in Sports and Exercise Journal have shown that students who participate in sports are less likely to drop out of school, consistently have higher grades, and are more likely to seek a post-high school education than students who do not participate in sports. Without dedicated coaches to lead high school sports programs, students would miss out on the benefits of sports.

"Texas high school and middle school coaches are unique in that they are integral to the schools and communities they coach," said Joe Martin, Executive Director of the Texas High School Coaches Association (THSCA). "Public school coaches are full-time teachers, department chairs, hall and cafeteria monitors, disciplinarians, and grief counselors. They are field trip bus drivers, pep rally leaders, part-time field and facility maintenance workers, security guards, and janitors. They are the first to arrive on campus and the last to leave at night. But above all, they care for students and the community without expectation of praise and recognition. That is why we are thankful that Texas Legislatures voted to create a day specifically for our school coaches; Texas High School Coaches Day will be celebrated to recognize the incomparable role that Texas coaches play in our communities." Schools are asked to participate in Texas High School Coaches Day by recognizing their coaches through social media, pep rally recognition, thank you cards, and other creative ways. Young ran for 231 yards and three touchdowns while Blocker ran for 208 yards and two touchdowns, Young also threw for 61 yards and a score as the Falcons wore down Iordan on the way to the win. The Falcons' defense also stepped up, not allowing a touchdown in the second half and limiting Jordan especially in the run game, where they only gave up 67 yards.

Paetow meanwhile won its second in a row by beating Taylor. The Paetow defense was huge in the game — the Panthers held Taylor to under 200 yards of total offense while recording three interceptions and stopping Taylor multiple times on fourth down. Offensively, Jamaal Comminie had 48 yards rushing while Kaleb Molina added 38 yards on the ground and a touchdown. Jackson Farrar only completed one pass but it was for a touchdown to Jabari Bush.

Tompkins will try to do the same thing they have been doing, using a bruising run game to get ahead and control the clock while getting turnovers and stops on defense. Paetow will try to do the same things on defense, where they have been excellent, while the Panthers will try to be more explosive on offense as they try to win a third straight.

Taylor (5-4, 5-2) vs. Katy (8-1, 7-1), 7:15 p.m. at Legacy Stadium

Last year: Katy 49, Taylor 7 • What looked like it might be a

battle for the District 19-6A championship coming into last week now is just a game for bragging rights,

as both Katy and Taylor are locked into their positions in the playoffs and the final district standings.

Katy comes off a big win against Seven Lakes, which was the Tigers' seventh straight win and kept them unbeaten in district play. Katy also managed to clinch the district title last week and the top spot in the playoffs out of the district by beating Seven Lakes and with Taylor losing. The Tigers' run game was once again a big catalyst in the win. Tremayne Hill, Romel Jordan and Chase Johnsey combined to dominate the game and combined to run for six touchdowns, while the Tigers' defense only allowed one touchdown in the game and kept Seven Lakes offense from ever getting into the game.

Taylor meanwhile, comes off a loss to Paetow that won't affect playoff chances but killed the team's chances of winning a district title, and the Mustangs will be looking to bounce back with a strong performance before heading into the playoffs. It was a defensive battle in the last game for the Mustangs from start to finish. Both teams were held under 200 yards of total offense in the game as both Taylor and Paetow struggled to move the ball and both defenses played well. The Mustangs held Paetow to just 11 yards passing in the game. Offensively, Daniel Bruns threw for a 109 yards and a touchdown, and Dante Archie caught five passes for 34 yards and ran for 41 yards while Jeremy McCullough had 32 yards receiving and a touchdown.

It will be a battle of strengths in the game. Both teams will want to run the ball and stop the run and both have strong front sevens and offensive lines. While both teams have their spots in district and the playoffs secured, both will be wanting to close out the regular season with a win.

Cougars announce first Big 12 basketball schedule

Seventeen regular-season home games and a Saturday exhibition against UNC Pembroke inside the Fertitta Center highlight the University of Houston's Men's Basketball 2023-24 schedule after the Big 12 Conference released complete team conference schedules on Tuesday.

Under the leadership of Head Coach Kelvin Sampson, Houston enters a new era when it tips off in the Big 12 for the first time in 2023-24.

All 18 Big 12 games will be shown on the ESPN family of networks with two contests being aired on CBS Sports (vs. Texas, Feb. 17 / at Baylor, Feb. 24).

Houston will meet Cincinnati, Iowa State, Kansas, Texas and UCF in home-and away series. The Cougars meet Kansas State, Oklahoma State, Texas Tech and West Virginia in home games inside the Fertita Center only and travel to face Baylor, BYU, Oklahoma and TCU on the road only.

The Cougars open league play when they play host to West Virginia inside the Fertitta Center on Saturday, Jan. 6. Houston goes on to meet Texas Tech (Jan. 17), UCF (Jan. 20) and Kansas State (Jan. 27) at home in the month with road tilts at Iowa State (Jan. 9), at TCU (Jan. 13), at BYU (Jan. 23) and at Texas (Jan. 29) to close out January.

In February, Houston opens the month against Kansas (Feb. 3) in the Cougars' first road trip to Lawrence, Kan., since Dec. 15, 1984. Additional road games in the month include at Cincinnati (Feb. 10) and at Baylor (Feb. 24) with home games against Oklahoma State (Feb. 6), Texas (Feb. 17), Iowa State (Feb. 19) and Cincinnati (Feb. 27) inside the Fertitta Center.




