Texas Emergency Management reminds Texans to report property damage from severe weather

CONTRIBUTED REPORT

AUSTIN — The Texas Division of Emergency Management (TDEM) on April 9th encouraged Texans impacted by last week's severe weather to report damage to homes and businesses by submitting an online damage assessment survey.

"As state emergency response resources remain engaged in the aftermath of severe storms and ongoing flooding in Texas communities, Texans who have experienced property damage are urged share this information through TDEM's self-reported damage survey," said Texas Emergency Management Chief Nim Kidd. "This information

will help officials identify community resource needs as well as assist in determining the state's eligibility for additional disaster assistance."

Texans can report severe weather and flooding damage to their property using the Individual State of Texas Assessment Tool (iSTAT) damage survey. The iSTAT damage survey can be filled out in English and Spanish online by visiting damage.tdem.texas.gov and clicking on "April 8-Ongoing Severe Weather Event."

Information provided through the iSTAT damage survey helps inform emergency management officials the extent of damage that has occurred and to identify any immediate resource needs in the impacted areas.

Additionally, the survey details aid officials in determining whether the state meets federal requirements for various forms of disaster

LAWPod is an initiative launched to address the legal access disparities in Harris County by offering legal resources and virtual assistance to the community at no additional cost, according to a press release from the Harris County Attorney's office.

"This ribbon-cutting ceremony marks a significant milestone in our commitment to enhancing access to justice and empowering individuals with the tools they need to navigate the legal system effectively," said a department spokesperson.

The event was attended by Deputy County Attorney Jonathan Fombonne, Harris County Commissioner Precinct 4 Policy Advisor Larisa Barreto, Harris County Law Library Director Andre Davison, Harris County Public Library Director Edward Melton and Houston Bar Association President Diana Gomez.

Board discusses superintendent contract, evaluation at meeting

The Board of Trustees for Katy
Independent School District met for a workstudy session on Monday, April 15th, twice
going into closed session — each time for
the purpose of discussing and considering
the Superintendent Ken Gregorski's annual
evaluation and contract, according to the
published agenda for the board meeting.

Gregorski has served the district since 2019, after being appointed to the position as Lance Hindt's replacement following allegations of bullying and plagiarism by the former superintendent.

Public comments at Monday's meeting were sandwiched between the two closed sessions. The lone speaker, Tana Weiss, spoke in support of Gregorski and his leadership through the pandemic, Winter Storm Uri and COVID.

No comments were made by the board

following either the first or second closed

In other action, the board discussed items including consideration of board approval of a contract for the connections of portable buildings at multiple campuses, and the repurposing of collaborative and flex space for classrooms at Robertson Elementary and Taylor High School, in order to accommodate student growth.

Fifteen portable buildings have been identified for relocation from four campuses including Campbell Elementary, West Memorial Elementary, Bethke Elementary, and McDonald Junior High. Campuses receiving the portables include Taylor High, Adams Junior High, Robertson Elementary, Faldyn Elementary and Youngblood Elementary.

Some of the campuses losing the portables







on Facebook supporting David Olson, who is running against incumbent Dawn Champagne for Position 7. The ad appeared in the Katy Times' publisher's Facebook feed on April 12. The organization's website also lists candidates that the group has endorsed in Texas school board races - and includes Olson, as well as Donovan Campbell, who is running for Position 6 against incumbent Rebecca Fox.

The organization's Facebook page declares, "We are a PAC dedicated to electing school board members nationwide committed to abolishing CRT." The PAC's priorities, as listed on its website 1776projectpac.com, include reversing learning loss experienced during the pandemic, transparency about what is being taught in the classroom as well as transparency about how tax dollars are spent, parental rights, school safety and protecting girls' spaces in locker rooms, bathrooms and girls' sports. The group also opposes DEI (diversity, equity and inclusion) programs and critical race theory while supporting a model of classical education in the arts and sciences and civics education.

The 1776 Project PAC claims on its website that it is the only national political action committee dedicated to electing conservative school board members. "We have a 62 percent win record, with over 200 successful candidates over the last three election cycles," states the website.

The PAC was founded in 2021 by Ryan James Girdusky, who is a New York native, according to his website ryangirdusky.com/ about-me. Since 2007, Ryan has worked in politics, starting out with New York City Councilwoman Helen Sears. He has worked on dozens of political campaigns including Michael Bloomberg for Mayor, Bob Turner for Congress, Liberty for All Super PAC, Bob Holden for City Council, and for the Logan Circle Group. He is also a writer whose work has been featured in nearly a dozen publications, and he has been a guest on television and radio shows.

However, both of the endorsed school board candidates deny association with this PAC. In answers to a candidate questionnaire created by the Katy Area Retired Educators group (KARE) and distributed to attendees at its April 10th meeting as well as through their electronic newsletter, the group asked: "Have you received or been promised campaign funds from any individual or organization (PAC) outside of the Katy area? If so, who are they and do they support or identify with an agenda? What is their purpose? Olson's response: "I am not involved in working with nor raising money through any PAC. Any

Campbell said in response to the same questionnaire: "As a candidate, I am not involved in actively working with any PAC. I have received money from With Honor, a veteran-founded, veteran-run, non-partisan PAC dedicated to supporting veterans who wish to serve civically. Rve, their CEO and co-founder, served in the Marines at the same time as I, and he's a friend of mine with a strong record of bipartisan public service and high personal integrity. With Honor's mission is to "strengthen democracy by fighting polarization with principled veteran leadership," and, among other things, With Honor has supported efforts to reduce the tax burden on Gold Star families - families who have lost a loved one in military service - as well as efforts to provide more Special Immigrant Visas for translators who served alongside US forces in Iraq and Afghanistan. I'm honored that they chose to support me."

Rebecca Fox, the Position 6 incumbent who is running against Campbell said in her response: "I have not received or been promised campaign funds from any PAC outside of the Katy area in any of my campaigns or service to the district." Dawn Champagne, the Position 7 incumbent facing Olson, replied to the questionnaire saying simply: "I have not."

Fox and Champagne are both supported by a local Facebook group called KEEP (Katy Educational Excellence Partners) which has over 580 members, according to data from Facebook.

ton Labs into the new building. The new facility is a significant milestone for the company as this expansion, facilitated in partnership with Partners Real Estate, signifies a 340% increase in their manufacturing and operational capabilities. The company now employs 18 to 20 workers, company officials said, but declined to share annual revenues.

According to a brief history provided by the company, NanoTech Materials:

- · Started as an operation reminiscent of a scene straight out of "Breaking Bad" (minus the illicit activities).
- · Pivoted to a three-year stint in Halliburton Labs, where the company worked through multiple certifications, including ISO 9001, and testing capabilities (including setting an egg on fire).
- Is now further scaling to support strong customer demand and solidify its position in the innovation ecosystem in Houston.
 - Was supported by one of the largest

independent commercial real estate firms in Texas, Partners Real Estate.

The ribbon cutting ceremony was held in the early evening, followed by demos, free food trucks, music, and drinks. Mike Francis, Co-Founder and CEO of NanoTech Materials, was on hand to greet guests.

Houston, known for its prominence in the oil industry, is witnessing a transformative shift towards sustainability and innovation, particularly within the clean tech sector and NanoTech is a perfect example," said Francis. The venture-backed startup is revolutionizing how the construction industry is approaching climate-resilient construction materials, including fireproofing materials, cool roof coatings, and more, he added.

According to his LinkedIn profile, Francis, who lives in the Kelliwood Estates area of Katy, holds a Bachelor of Science degree from Texas A&M University and an MBA from Rice University.

Community health workers in Katy help combat care disparities

Bread of Life Academy graduation highlights impact toward health equity in communities across the Greater Houston area

As April marks National Interprofessional Health Care Month, Bread of Life Academy, a program under the nonprofit Bread of Life Inc. (BOL), hosted a special graduation ceremony on Friday, April 12th, at Bread of Life Inc. in downtown Houston for Community Health Workers (CHWs). The nearly three dozen graduates are fully trained and equipped to begin helping communities in need, at facilities like at Christ Clinic located at 25722 Kingsland Blvd #111, Katy, TX 77494.

CHWs at Christ Clinic help uninsured Katy residents address non-emergency medical needs. They provide non-judgmental, non-coercive provision of services and resources to people who are marginalized or stigmatized, experiencing housing instability or homelessness, injecting substances, live with or are at risk of Hepatitis C Virus or Human Immunodeficiency Virus, and are experiencing greater barriers to entering treatment or recovery

"Having a Community Health Worker (CHW) at Christ Clinic to serve Katy has been an incredible blessing," said Lara Mautz, Executive Director, Christ Clinic in Katy. "A CHW is a real person that can relate to the people in our community, deepen our relationships, and leverage our connections to improve lives beyond healthcare. These kinds of tailored interventions not only improve outcomes, but display love and humanize the healthcare experience."

Bread of Life Academy is dedicated to providing educational opportunities for underserved individuals in Houston, equipping them with essential skills to enhance their employability in the healthcare sector. The program focuses on training and certifying students as community health workers (CHWs) and phlebotomists, addressing critical shortages in these allied health professions.

"The demand for allied health jobs in Texas has reached unprecedented levels, significantly impacting healthcare accessibility and quality," said Dr. Morgan Rasmus Alfred, Vice President of Education & Director of Bread of Life Academy. "Our graduates play a vital role in bridging this gap, particularly in marginalized communities, where access to healthcare services is often limited.'

The graduation ceremony on April 12 celebrated the achievements of 35 students who will receive certificates in phlebotomy and community health work, like Angel Harrison, a dual-certified Community Health Worker and phlebotomy student. "I was homeless and had just lost my job when I enrolled in the programs. When I read up on what a Community Health Worker was, I knew I had to be one because I wanted to be support where I didn't have support. Bread of Life provides me with the skills, tools and knowledge to conquer life's barriers."

The Bread of Life Academy receives support from the Quest Diagnostics Foundation as part of the Quest for Health Equity (Q4HE) initiative. This initiative aims to address health disparities in marginalized communities across the U.S. by providing resources,

funding, donated testing services, and education. In Texas, the shortage of CHWs is a pressing concern, with only 4,139 actively licensed CHWs in the state in 2020, representing a significant increase over the past decade. Despite this growth, Texas still lags behind the national average in CHW per capita ratio, emphasizing the need for programs like Bread of Life Academy.

"My heart and joy are community-based," Hammond said. "I am the happiest as a servant to others in the Lord's name. It is very humbling to receive this honor, and I am blessed to be able to serve my community through my faith."

Under the tutelage of his stepfather, who ministered at their hometown church in Virginia, Hammond began teaching Sunday School at 12 years old and became a licensed minister when he was 14. Hammond was ordained into the church at age 18, just one week before he married his wife, Marcia.

After moving to Houston in 2013, Hammond established a small church in Katy. Through his ministry, he connected with Pastor Henderson, and the two quickly formed a friendship built on their faith and passion for community stewardship through God's word.

As TLHC began to rapidly grow, Pastor Henderson asked Hammond to lead the Church's second satellite campus. The West Campus opened in March 2020; however, restrictions on public gatherings due to the COVID-19 pandemic went into effect just one week after the first

Although TLHC remained open virtually for members, Hammond always longed to return to in-person ministry and worship. In March 2022, TLHC moved the West Campus to its current location at 16219 Clay Road in the Bear Creek area. Aidan Morrison walked three steps back, paused, took a deep breath and looked through the wall at his target 30

It's something Morrison had done hundreds of times, that he had spent hours practicing and honing his craft on, but this was the biggest moment he had ever taken a free kick in.

Nothing fazed Morrison in that moment, not the crowd noise, not the opposing team, not the significance of the chance.

Morrison released his breath, ran up to the ball and bang. It sailed through the air, curled around the wall of defenders, went past the goalkeeper and found the lower right hand corner of the net in extra time, giving Seven Lakes a 2-1 lead in the 97th minute of Saturday's Class 6A State Championship as the Spartans went on to beat Flower Mound 2-1 in extra time to secure back-to-back state championships.

was just an amazing feeling." Seven Lakes dominated for much of the game, but got forced to extra time from one Flower Mound moment. The Spartans got their first big chance of the match 16 minutes in when Kortay Koc got past the defense and lifted a cross to the back post that SeanCarlos Rivera just missed out on connecting with.

GEORGETOWN - Seven Lakes had belief

The Spartans had to go through adversity and were tested every step of the way, but they believed they had what it took to get to Georgetown and win.

That belief never wavered, but on Friday, things went against the Spartans and despite fighting for 80 minutes, Seven Lakes (19-4-5) fell to Prosper (25-2-2) 3-0 in the Class 6A State Final, ending the Spartans' season after a great run where they went their furthest in the playoffs in over a decade.

They fought for everything this year and went through so much adversity and I'm so proud of them for getting to this point," said Seven Lakes head coach Kaitlyn Eidson. "There were only two or three starters

returning from last year's team and so this year really brought them together and they bonded. This team never stopped fighting.

The Newcomer of the Year Award went to Taylor senior Timya Grice. Grice had a very strong year where she helped Taylor reach the playoffs for the first time since 2019. The Mustangs finished with a 28-7 record, going 12-4 in district play and finishing third overall in district.

Tompkins led the way with three picked on the district's first team. Senior guard Gabbie Panter, junior guard Rihanna DeLeon and sophomore guard Sascha Coughran were all named to the first team after helping lead the Falcons to a co-district championship with Seven Lakes. 

Seven Lakes kept pressing into the second half and found its goal in the 48th minute when a rebound fell to Noa Stasic, who volleyed a laser of a shot past the Flower Mound keeper and into the net.

"Noa just plays for every guy out there," said Seven Lakes head coach Jimmy Krueger. He plays for his friends and his second family and you could see it tonight — he gave us every single bit of himself, he's just a special player and such a nuisance for opposing teams. But the biggest thing is he has such love for his teammates out there."

The Spartans nearly found a second just a few minutes later when Kortay Koc got past the defense, but a kick save from the Flower Mound keeper kept the Seven Lakes advantage to one. Seven Lakes continued to press and try and find a second, but Flower Mound got an equalizer against the run of play in the 69th minute when they got a throw in deep in Seven Lakes territory and a long throw found Carter Simpson, who found the net from just outside the 6-yard box.

'We score goals," Krueger said. "That's the one thing we didn't want to give up was a long throw in goal, but when we did everyone just flipped a switch and said 'ok lets go get the winner."

Flower Mound tried to get the game to penalties once it went to extra time, but Seven Lakes kept pushing and they got their reward when Koc was fouled in the 97th minute, with Morrison scoring the game winning goal from 30-yards out.



"So much emotion just came through as soon as Aiden scored that goal," Stasic said. "There was no doubt in any of our minds, I walked up to Aiden and he just looked at me and said 'this is going in,' and I just knew. Watching that goal go in was the best feeling.

This Spartans senior class will be one that's sorely missed. It's a senior class that went to three straight state tournaments and won back to back state titles. It's a class that every future team will have the challenge trying to meet the expectations of. But for these seniors this was the defining moment, they helped create a dynasty and they cemented their place in history on Saturday, becoming the first ever Class 6A boys team to win back to back state titles.

"It's unreal, with these guys by my side it just makes it so much better," said Morrison, who was named the games MVP. "They're some of my best friends I have ever made in my whole life. To go out on top is absolutely unreal. It's perfect — that's the only way to put it, perfect."


